  1. Shape & Size; Venetian Arch, 48" x 36"
  2. Color: Green Sign / Tan Lettering
  3. Symbols; Tree TE02
  4. Lettering Style Seagull Bold - Left side of tee symbol " Est." right side of the tree symbol " 2012". First line with large letters, Collins Park. Under that with smaller letters " Friends gather here." with Seagull Bold Italic.
  5. Custom V-Groove letters add depth and dimension
  6. Double -sided and both show the same information. **Change it to single sided sign.**
  7. Posts: Mitered post- color- Evergreen. 4- 8 " and 2- 6', total of 6 posts. There are 3 posts on each side. Yoshida-Travers will get the proof of sign.
  8. Chairman Ober agreed to order 2- 8" benches (KBG1115) and a picnic table (07BM1521) at the Collins Park, which is made of maintenance free recycled plastic material. Yoshida-Travers will order.
