

STATE FEES

State fees are based on the weight of a vehicle. Vehicle weight is located on the drivers' side door jam.

0-3,000 lbs. \$2.60 per month

3,001 – 5,000 lbs. \$3.60 per month

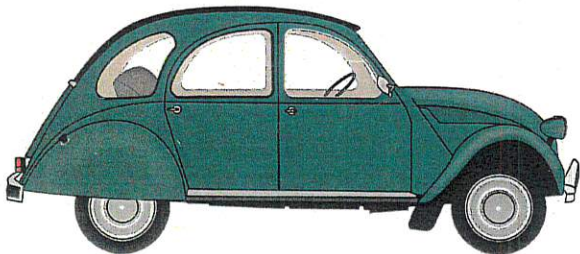
5,001 - 8,000 lbs. \$4.60 per month

8,001 - 73,280 lbs. \$.08 per hundred lbs. per month or .96 cents per hundred lbs. gross weight per year.

EXAMPLE

A 12-month registration on a vehicle with a GVW of 7,300 lbs. is \$55.20.

(12 months x 4.60 per month = \$55.20)

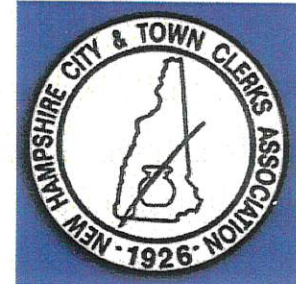
If Registration is more than 12 months, the remaining months will move into the lower millage rate. Add this amount to the above 12 months.

TOWN REGISTRATION PERMIT FEES

What will you need to register your newly purchased vehicle?

Motor Vehicles 2000-2023

- ◇ Title Application from NH dealer (Blue Town Clerk Copy) or
- ◇ Certificate of Origin & Bill of Sale or
- ◇ Prior Title properly signed over & Bill of Sale

Title Exempt Vehicles 1999 and older

- ◇ Vin Verification 19A & Bill of Sale; or
- ◇ Photocopy of Title & Bill of Sale;
- ◇ Or Prior NH Registration & Bill of Sale

LIST PRICE

TOWN FEES ARE BASED ON THE MANUFACTURERS' LIST PRICE (LIST PRICE DOES NOT CHANGE FROM YEAR TO YEAR).

Millage: A tax rate on property, expressed in mills per dollar of the value of the property.

The Mill rate to be charged on a motor vehicle is based on the model year of the vehicle and continues for the next 12 months, including the month of registration. RSA 261:153-4

The first 5 year's of a vehicle's registration price is subject to the following millage rates:

2022-2023	18 mills x list price
2021	15 mills x list price
2020	12 mills x list price
2019	9 mills x list price
2018	6 mills x list price
2017 & older	3 mills x list price

Each millage rate above is applied for 12 months

A new vehicle will be registered for no less than 5 months, but no more than 16 months.

Registrations are renewed annually in the owner's birth month. Exceptions: Business owned .

EXAMPLE

A 14-month registration of a 2022 vehicle with a list price of \$10,000 would be charged

12 months @ 18 mills = \$180.00

(\$18.00 per \$1,000 of the list price)

02 months @ 15 mills = \$25.00

(\$15.00 per \$1,000 of the list price divided by 12 months = \$12.50 per month x 2 months = \$25.00)

A mill equals 1/1000 of a dollar and is charged on each dollar of the vehicle manufacturer list price.
